**\*Initial Enrollment, Tuition, & Stops:** A student will be enrolled upon payment of **\$120 for the first four lessons** and completion of this agreement. If necessary, an adjustment will be made on the second month's tuition to bring the payments to a first-of-the-month basis.

Lessons are \$30 per half hour, billed monthly. Four week months will be \$120. Five week months will be \$150.

**Stopping lessons:** A student may drop from the schedule at any time by notifying me in writing, Email, or text. The notice must be given 1 week in advance of your lesson time for charges to stop immediately. If any unused tuition remains after stopping, a refund will be issued by check in the next billing cycle

**\*Financial Commitment To Reserved Time:** As long as a student remains scheduled for a thirty-minute time block on my Teaching schedule, that thirty minutes is reserved exclusively for that student. That student (parent) shall remain financially responsible for the reserved time and will continue to be accountable for the monthly payment until the student's name is removed from the schedule and the account is closed.
